## **IMPORTANT NOTICE**

At the outset, we wish to appreciate the guardians for their overwhelming support to the online classes which we are extending as per the best possible standard to over 1500 students. The support of the guardians and the efficiency of our teachers have been the reason why our online classes and online evaluation could match the best practices of online education during this pandemic. Clearly, our students are being taught and evaluated at the maximum possible efficiency so that they can make the best of the education in this academic year.

We had earlier informed through our website notices that we shall not be taking fees for the following heads in 2020-2021. The heads include:

- a. Games and Function;
- b. Library Fee;
- c. Library Caution Fee;
- d. Computer Fee;
- e. Magazine Fee;
- f. Fee Book;
- g. Electricity & Generator Fee.

We had already decided and informed that we have not increased the monthly tuition fees payable in the year 2020-2021.

Our tuition fee schedule in our website notice dated 14/8/2020 had been arranged in such a way that maximum possible flexibility can be extended in the SBI Collect payment schedule.

We would take this notice to inform you that as per recent litigation in the Hon'ble High Court, Calcutta and Hon'ble Supreme Court of India, a reduction of the monthly tuition fees by 20% has been called for since April, 2020.

Accordingly we have decided the following arrangement for adjustment in monthly tuition fees payable for the academic year April, 2020 to March, 2021.

- a. Since there is a requirement of 20% reduction in monthly tuition fees for the aforesaid period of 12 months of the present academic year, we have decided, as a way of adjustment, to waive and **not take the fees of two full months, and waive the fees of 40 % of another month's fees**, so as to give the overall 20% reduction benefit for tuition fees payable in academic year 2020-2021.
- b. In order to extend this adjustment throughout the remaining months of this academic year's payment schedule, we have decided that we shall NOT be taking the fees for the months of NOVEMBER, 2020 and JANUARY, 2021, and we shall not be taking 40% of the monthly tuition fees of FEBRUARY, 2021.
- c. Accordingly, the revised SBI COLLECT payment schedule\* for the remaining months of this academic year 2020-2021 shall be as follows:
